- A. New York State Catholic Daughters will award three (3) \$1,000.00 scholarships to a daughter, son or dependent of a member of a NYS Catholic Daughter Court.
- B. The member must be in good standing and belong to a court for at least two years or be a charter member and have attended a minimum of three (3) business meetings in the current court year.
- C. The candidate for scholarship must be a graduate from high school for the term ending June 2022.
- D. Each application must be filled in completely and have all required attachments (listed below) to be eligible for consideration.
  - 1. Copy of college acceptance letter.
  - 2. Letter of recommendation from applicant's Pastor.
  - 3. Applicant's essay describing their view of a life of service, minimum 200 words.
  - 4. List of all volunteer activities, including dates and approximate hours.
- E. Each application must be signed and verified by the COURT REGENT.
- F. All scholarships will be awarded on a basis of essay and service.
- G. ANY APPLICATION POSTMARKED AFTER APRIL 15<sup>TH</sup> WILL NOT BE CONSIDERED.
