## **ELIGIBILITY GUIDELINES AND APPLICATION**

In an effort to provide financial assistance to a worthy candidate who wishes to pursue a **Career in The Medical Field**, the family of Ann Carey and the Catholic Daughters of the Americas, Court Ave Maria #832 of Kings Park, NY will award a scholarship in the amount of **\$1,000.00** to any child, grandchild or dependent of a CDA Court Ave Maria member in good standing or a member of our JCDA Court. The award will be paid in one lump sum to the student upon completion of their first semester, and receipt of a transcript from the College or Technical school.

#### **Eligibility Criteria:**

- 1. The must be a child, grandchild, or a dependent of a CDA Court Ave Maria member in good standing, or a member of our JCDA Court.
- 2. The applicant must be an incoming College or Technical school freshman.
- 3. The applicant must have been accepted and be enrolled in an accredited 2 year or 4 year college by May 1, 2023.
- 4. The applicant does not have to be a resident of Suffolk County.
- 5. Applicant must provide information on how they plan to pay for their education.
- 6. An applicant who is in receipt of <u>a full scholarship</u> from any other source, is not eligible.
- 7. A completed application form along with all requested attachments must be returned by the deadline date.

#### **Confidentiality**:

- 1. Applications will be submitted to a scholarship chairman and all identifying information will be removed.
- 2. Only the scholarship winner will be announced to all committee members and Court members.
- 3. Any Court member who has a child or grandchild applying for the scholarship cannot be on the committee.

#### **Procedure:**

- 1. A committee of CDA Court Ave Maria members will be formed to review the applications and determine if the applicant meets all eligibility criteria.
- 2. This committee will be made up of 3 members who will review all the information and choose a winner based on scholastic achievement, financial need and the applicant's essay.

### **Award Presentation:**

• The student will receive notification of their award from the Scholarship Chairman and will be invited to the Catholic Daughters meeting in May to receive a certificate and be recognized by the membership.

• Payment will be made upon completion of the first semester and receipt of a transcript (not a copy) from the accredited college attending.
