

CATHOLIC COLLEGE SCHOLARSHIP APPLICATION

**ELIGIBILITY**

1. This scholarship is open to any child, grandchild, dependent or member of a Suffolk County CDA Court who has been a member in good standing for at least two years and has attended a minimum of 5 business meetings per year or a member of a Suffolk County Junior CDA Court.
2. Applicant must be an incoming Freshman, accepted by a Catholic College by May 1<sup>st</sup> of the current year.
3. Applicant does NOT have to be a resident of Suffolk County.
4. Applicant in receipt of a FULL scholarship is not eligible.
5. Applicant in receipt of another grant, initiatives or partial scholarship **DOES NOT PROHIBIT APPLICANT FROM RECEIVING THIS SCHOLARSHIP.**

**DEADLINE: THIS APPLICATION MUST BE RECEIVED NO LATER THAN MAY 20, 2023.**

**AMOUNT OF SCHOLARSHIP**

A total scholarship of \$3,500 is to be paid over a four-year period; \$875.00 per year, payable to a four year college.

**FORFEITURE**

If for any reason, the winner does not complete 3 years of a 4-year Catholic College, the unused portion of the scholarship will be forfeited.
