## Prayer Warriors In Virtual Battle for Mercy

When last I wrote to you the world was a far different place. We were all preparing for the celebration of Easter and Spring was just around the corner. Never in our wildest dreams did we expect the pandemic that has overshadowed us and changed the way we live, how we interact with our families and friends, and the way we practice our faith. So much has changed and yet, He is unchanged. To quote St. Augustine of Hippo, You have made us for Yourself, Lord, and our hearts are restless until they rest in You.

In the March issue of The Rising Dawn, I suggested that each of you consider preparing for Divine Mercy Sunday, and for the graces Jesus wants to give us and I asked you to share it with your Courts. A group of us, affectionately dubbed the Divine Mercy prayer warriors, started the Divine Mercy Chaplet Novena on Good Friday and we continued through to the Saturday before Divine Mercy Sunday. Each day at 11am, on the Catholic Daughters NY State Facebook page, we gathered and prayed for a different intention, as Jesus instructed through St. Faustina: Day 1: All mankind, especially sinners; day 2: the souls of priests and religious; day 3: all devout and faithful souls; day 4: those who do not believe in God and those who do not yet know Jesus; day 5: the souls who have separated themselves from the Church; day 6: the meek and humble souls and the souls of little children; day 7: the souls who especially venerate and glorify His mercy; day 8: the souls detained in purgatory; and day 9: souls who have become lukewarm.

Jesus said, I desire that during these nine days you bring souls to the fountain of My mercy, that they may draw therefrom strength and refreshment and whatever grace they have need of in the hardships of life, and especially at the hour of death (Diary, 1209).

I was overwhelmed at the response that I received from these incredible Catholic Daughters. The strength and the faith of these women is remarkable. For nine days, by way of Facebook, we lifted up our hearts to the Lord, trusted in His mercy and love and prayed faithfully each day. On Divine Mercy Sunday, we 'attended' televised Mass either from our home parishes or from the National Shrine on Eden Hill in Stockbridge, Massachusetts. We also together prayed the Chaplet at the Hour of Mercy that day at 3pm. The joy I felt and the joy that I'm sure my sisters felt was great. Remember, Jesus promised, On that day the very depths of My tender mercy are open. I pour out a whole ocean of graces upon those souls who approach the fount of My mercy. The soul that will go to Confession and receive Holy Communion\* shall obtain complete forgiveness of



sins and punishment. On that day are opened all the divine floodgates through which graces flow.

What a wonderful experience and what a treasure to have experienced it with these **Prayer Warrior** sisters. It was much a wonderful way to begin the day and so we have continued to pray the Chaplet of Divine Mercy. At 11am, Monday through Friday, we still pray the Chaplet together on the Catholic Daughters NY State Facebook page. I can't promise how long we will continue as a group, but right now, as we face an uncertain future, we are together, gathering strength for another day. I ask you to join us and be a prayer warrior too. Experience the tender mercy of the Lord as we pray, **Jesus, I trust in You**.

It is my honor and pleasure to announce that Ct. Our Lady of Victory #375, Huntington, has been selected as the NYS Spiritual Enhancement most outstanding project for the reporting period, February 1, 2019-February 1, 2020. Congratulations to Regent Virginia Grausso, local chair Elyse Hayes and the entire Court. The title of their project was Mini Lenten Retreat. Factors in the ultimate selection of this project included the large number of participants from the Court, the parish and other courts, Reconciliation, Mass and the Rosary, the decision to improve the experience over the previous year's retreat by the addition of the Divine Mercy Chaplet and Exposition of the Blessed Sacrament, and the inclusion of a talk by their seminarian. The Court reported that the day resulted in an abundance of prayerful encounters.

## Why Is God Doing This To Us?

OK, so it doesn't need to be said again but, here goes: the novel Coronavirus COVID-19 has changed our world, thrown us into a tailspin, challenged us in ways we could have never imagined, 362,000+ deaths worldwide (at the time of my writing), over 100,000 deaths right here in the US! How it started, how it spread, how slowly or quickly any governement acted—that wasn't the concern of some. Many peopl,e are just asking: Why is God doing this to us? Why is God allowing this to happen? Why does God ever let trouble, problems, evil attack His faithful children.

The problems you face will either defeat you or develop you—depending on how you respond to them. Unfortunately, most people fail to see how God wants to use struffles for good in their lives. They react foolishly and resent the difficulty rather than pausing to consider what benefit they might bring.

God works in us and through us at all times: the good and the bad, the ups and the downs, in the hills and the valleys. In all these difficulties lead us to rely on God's promises and help us to trust Him completely.

**God uses obstacles to direct us.** Sometimes God must light a fire under each of us to get us moving. Problems often point us in a new direction and motivate us to change. Many people say that God has used this pandemic to get out attention; to make us stop; to make us take stock; to give our planet a respite from pollution. Sometimes it takes a painful situation to make us change our ways.

**God uses struggles to inspect us.** I have heard it said that people are like tea bags, if you want to know what's inside them, just drop them in hot water! What do problems reveal about you? For myself, it hasn't always been pretty, but I can say that through it all, I know that rely on and trusing in God has gone much better for me that just trying to handle things on my own.

God uses problems to correct us. Some lessons we learn only through pain and failure. It's likely that as a child your parents told you not to touch a hot stove. But you probably learned by being burned. Sometimes we only learn the value of something—health, money, a relationship—by losing it. Look at us now, although we miss haircuts and restaurants, we miss our firends, family and gathering at mass a whole lot more!.

**God uses problems to protect us.** A problem can be a blessing in disguise if it prevents you from being harmed by something more serious. There's a story of a woman who was fired for refusing to "fix the books" for her boss. Unemployment was a problem—but it saved her from being convicted ater when management's actions were eventually discovered and he went to jail. Sometimes, we can't see the silver lining, the light at the end of the tunnel, the window God opens when He shuts a door; but we know that above all, He will protect us.

God uses difficult situations to perfect us. Problems, when responded to correctly, are character builders. God is far more interested in your character than your comfort. Your relationship with God and your character are the only two things you are going to take with you to eternity. We can rejoice when we run into problems—they help us learn to be patient. And patience develops strength of character in us and helps us trust God more each time we use it until finally our hope and faith are strong and steady.

God is at work in our lives even if we don't understand how He works. The trials He brings us to, we have faith that He will also bring us through.

## The Blessing of Time at Home with Family

As I begin my article for this issue of the Rising Dawn, I would like to first announce the most outstanding project for the NYS Family Circle of Love Reports. This project has been submitted to the National Chairperson. Please know that this decision challenged me to review the submissions over and over and required a detailed process of elimination. Although there were so many submitted reports that could have been chosen, I was restricted to picking only one of them. And the winner is: The Food Pantry Collection reported by Court Genevieve Walsh #918. Goshen.

The court teamed up with **St. John's School** to collect items needed for the **Goshen Ecumenical Food Pantry**. It was a very impressive project in the fact that they collected over 400 items during Advent and 500 items during Lent that involved a united partnership of CDA, teachers, parents and students in Kindergarten through 7th grade. The project began by the 7th graders writing a 3-5 minute presentation about the Goshen Ecumenical Food Pantry and presenting it to the children attending the St. John School in Grades K-8. They instructed Kindergartners to donate hats/mittens/gloves; Grades 1-4 to donate toothpaste, toothbrushes, mouthwash, soap, shaving cream, shampoo, and conditioner; and Grades 5-8 to donate desserts. The 7th grade class then collected and inventoried the items and announced the winner with the prize being a Dress Down Day. Truly a united effort that involved so many.

As we move into the next cycle of Family Circle of Love Projects, I am sure that the impact of COVID-19 pandemic and the mandated quarantine has given us an insight as to what is now considered valuable and essential treasures. We have seen so much death and chaos in this pandemic crisis, but with prayer, faith, and love we have also seen so many blessings. It takes a person with faith to see that God is trying to tell us something. Many years ago, I heard this phrase If Satan can't make you bad, he'll make you busy. (Pastor Adrian Rogers). With curiosity, I asked members of the community to share their experience on how this crisis impacted them and each response rang a similar tune.

Teachers responded in that they found some students did better academically with online schooling because it initialized a

productive and compassionate relationship between teachers, parents and students. Classroom virtual tours of museums were set up and was very successful in that the teacher, students and their parent/grandparent/guardians could enjoy this experience together.

My personal journey was to join a family of **Praying Angels**, formed by the State and National CDA Sisters in Christ to serve, 3 times a day, as **Spiritual Warriors** against this invisible war, creating a strong and vital bond of Love, Protection, Healing, Comfort, Peace, Faith, and Hope to each other and all who need our prayers.

But what really summed it up was an in-depth reflection from **Karen Best-Arnold**, a parent of 2 teenagers and a School Speech Therapist:

Time. We never seemed to have any. Down time, that is. School. Practice, Games, Rehearsal. Lessons. Homework. Paperwork. Meetings. True, we did much of this as a family unit and I...we..loved the organized, sometimes (probably more often than I'd like to admit) disorganized, chaos. Racing to do it all to get it all done.

Then the school closure happened. Countless emotions, so much to navigate. Heartbreak for all those suffering, fear for our loved ones and for us. But then came the Blessings of long and respectful conversations between teenage siblings, my daughter gaining a whole new appreciation of the outdoors by experiencing the presence of God through Nature's sounds and smells and my teenage son sharing that he never realized how difficult my job was and the newfound appreciation that he has for it.

The most precious blessing that will always stay with me (and I pray with the rest of the family) are the profound moments experienced at our kitchen table on Holy Thursday as we listened to our deacon's reflection of the Last Supper and on Good Friday as we each took turns reading the Passion. These moments were filled with God's presence that brought us a tremendous peace, warmth and incredible comfort of knowing that He is with us always, especially during times of turmoil and uncertainty. On Easter Sunday, we feasted and relaxed with in-laws, finding ourselves beyond grateful for God's grace and the gift of family, friends and down time that allowed us to be lifted up and never again taken for granted.

May the wisdom gained through faith, creativity and survival skills bring a permanent and positive clear vision to our future endeavors. God Bless each of you.

Last year, NY State launched a statewide military appreciation project called **The Thank You Project**. The purpose of the project is to collect thank you cards that will be mailed to service personnel in all branches of the armed forces throughout the year.

The Thank You Project allows us each to not only show our gratitude to our service people, especially those deployed, but afford us an inexpensive and meaningful way to involve many facets of our community in the effort.

Sadly, only 18 courts chose to participate in our first attempt at this project to support the military, but those courts wrote and/or collected 2,956 thank you cards for our troops!

While that number is great and truly appreciated, if we did nothing other than had each member in our state write one card, we would have collected over 5,000 notes of thanks for our deserving military personnel.

This year, **Ct. St. Pius X #1690, Levittown,** has agreed to chair the project for the state! **Sandy Leonard** will accept all packages at her home and the court members will work together to count & sort them.

We are asking every court to participate in this event.

### Here's the idea:

Speak to your pastor about securing a space on a Sunday morning. Invite everyone to stop by after mass to write a thank you card to the troops. Pretty simple, huh?

Get some colored paper, index card, blank thank you cards, markers, crayons, etc. Post some sentences for kids to copy or ideas for messages of thanks on the walls.

### Tips to remember when writing your letters:

- Be positive, upbeat and thankful for their service
- · Share a little info about yourself like hobbies, pets, etc
- Talk about things happening around home like the weather, sports, etc.
- A great way to start your letter is "Dear Service Member" or "Dear Friend"

### Some things NOT to do when writing your letters:

- Kids' drawings are great but do not use glitter or any other crafting materials (googly eyes, puffy stickers, pipe cleaners, etc.)
- Do not discuss inappropriate things
- · Avoid politics or political statements
- Avoid lengthy religious discussions but saying you are praying for them is great
- Avoid making holiday-specific cards, as the troops will be sent letters throughout the year.

(Suggestion: print or rewrite these guidelines and post for all to see at your event.)

### The guidelines:

- Do NOT include envelopes when writing cards—it will only slow down the sorting!
- Bundle letters in groups (typically in groups of 25, 50, 100 or 250 is best for a large amount).
- Please add a note to the top of your letters noting how many are in each bundle.
- Place the letters/cards in a manila envelope or small box and send them to:

Please have your bundles organized and sent to Sandy Leonard before November 1, 2020. We will make sure the letters get into the hands of the right group to be sent to our military men and women in a secure and timely manner.

No items, trinkets or monetary donations for the troops will be accepted—please do not include any in your letters. However, the state will be accepting donations to help with shipping the letters, so perhaps you could place a donation bucket at your event for the same purpose, then use what you need to mail to the Chairman and send the rest as a donation (a check made payable to Catholic Daughters of the Americas).

While we are happy to receive thank you cards from the members of your court, but this could be so much more. The event could be opened to Religious Education classes, scout troops, parishioners, even the community at large! What a great way to publicize CDA and your court while supporting our troops. You could serve coffee/juice/bagels. Or have a bake sale at the same time. Be sure to have your court banner prominently displayed and your members there to help adorned in their purple CDA shirts. This is a great opportunity to publicize your court while showing your patriotism and support for our military. Just make sure the emphasis is on The Thank You Project and the letters and cards that are being written.

## Trust God!

We have never lived at a time in our lives where we could not attend Church for the Holy Sacrifice of the Mass nor be able to receive Jesus in the Eucharist. A time when as loved ones are dying from this Coronavirus, they are unable to be surrounded by their family members or have a Catholic funeral. Catholics are called to believe that the **joy** of the **resurrection** cannot be taken away by tough economic times or an uncertain future.

New York State has been the hardest hit in our beloved America. The **State Bureau of Emergency Medical Services** issued a blanket DNR (do-not-resuscitate) order for First Responders. The First Responders were outraged and refused to follow the order. **Oren Barzilay**, head of the union, whose members include uniformed EMT's and paramedics, fumed at state officials: **Our job is to bring patients back to life. This guideline takes that away from us.** In less than a week, **State Health Commissioner**, **Dr. Howard Zucker**, rescinded the order!

As great as this victory was, we also had sad news: **Governor Cuomo** and the **NYS Senate and Assembly** voted to legalize surrogacy—paying a woman to carry a child that is not biologically related to her.

Court Queen of Life #2664, Commack, and their 40 Days for LIFE Campaign had half their members actively participate and they succeeded in saving the lives of two babies! Their loving witness was seen by the public and elected officials.

Court Rita #264, Cornwall, is very in tune with the United States Conference of Catholic Bishops and was able to contact their elected representatives on the Capable Unborn Child Protection Act, The Born-Alive Survivors Act and the Protecting Statutory Conscience Right in Health Care Act. They also alerted their members about the evil of the Equal Rights Amendment.

Court Ave Maria #832, Kings Park, was involved in promoting Catholics for Freedom of Religion and also participated in a 40 Days for LIFE campaign in Smithtown.

Resources. They include:

- Robes must be eleven inches off the floor.
- · White shoes need to be worn with robes.
- Stockings are optional but need to be nude or skin tone.
- Small stud earrings are allowed but no larger than the ear lobe.
- Rings and watches are allowed with robes.
- Slacks are NOT to be worn under the robes.
- Purses/handbags are NOT to be carried when in a procession.

It is an honor and privilege to be an officer of your court and we need to wear the robes with dignity and respect. Once again, I would like to congratulate the new local officers and know that the New York State board is always ready to assist you in the running of your court.
